

REPORT ON GRANTS ALLOCATED

We can advise that since our last Open Board meeting held 26 June 2025, the following grants have been approved by ILT.

Chatbus South Trust

A total grant to a level of **\$5,000** will be provided to assist with salaries of the two counsellors.

Cycling Southland Inc

A total grant to a level of **\$4,000** will be provided to assist with traffic management of the 2025 Tour of Southland.

Invercargill Musical Theatre Inc

A total grant to a level of **\$22,500** will be provided to assist with staging “Matilda” at Civic Theatre, July 2025.

Knox Presbyterian Church

A total grant to a level of **\$5,000** will be provided to assist with partial re-roof and construction of a new gravel carpark.

Queens Park Golf Club Inc

A total grant to a level of **\$8,735** will be provided to assist with re-roofing green keepers shed, website development and vouchers for prizes.

Touch Southland Inc

A total grant to a level of **\$7,500** will be provided to assist with operation costs, staff wages, office rent, playing field rent and phone costs.

Invercargill Schools Sing Out
